# FY23 BBDC GUN VIOLENCE PREVENTION WINTER MINI-GRANTS

### **OGVP OVERVIEW**

- OFFICE OF GUN VIOLENCE PREVENTION (OGVP), AND ITS PARTNERED GUN VIOLENCE PREVENTION EMERGENCY OPERATIONS CENTER, IS THE FIRST-OF-ITS-KIND IN THE COUNTRY TO ADDRESS GUN VIOLENCE USING A PUBLIC HEALTH APPROACH. THROUGH OFFICE OF GUN VIOLENCE PREVENTION, THE BOWSER ADMINISTRATION WILL FIRST SERVE RESIDENTS BY FOCUSING ON THE SMALL NUMBER OF INDIVIDUALS RESPONSIBLE FOR A SIGNIFICANT PERCENT OF GUN VIOLENCE IN THE DISTRICT.
- OGVP IS ALSO CO-CREATING PLACES BY FOCUSING ON THE SMALL NUMBER OF PLACES WHERE THE MOST GUN VIOLENCE IS OCCURRING ALL WHILE BUILDING THE EMERGENCY OPERATIONS CENTER WHICH COORDINATES VIOLENCE PREVENTION EFFORTS CURRENTLY LEAD BY DISTRICT AGENCIES, NONPROFIT PARTNERS, AND COMMUNITY-LEAD EFFORTS.

### DYRS OVERVIEW

- THE DEPARTMENT OF YOUTH REHABILITATION SERVICES (DYRS) IS RESPONSIBLE FOR THE SUPERVISION, CUSTODY, AND CARE OF YOUNG PEOPLE CHARGED WITH A DELINQUENT ACT IN THE DISTRICT OF COLUMBIA IN ONE OF THE FOLLOWING CIRCUMSTANCES:
  - YOUTH WHO ARE DETAINED IN A DYRS FACILITY WHILE AWAITING ADJUDICATION.
  - YOUTH WHO ARE COMMITTED TO DYRS BY A DC FAMILY COURT JUDGE FOLLOWING ADJUDICATION.
- YOUTH CAN BE INITIALLY COMMITTED TO THE AGENCY UNTIL AGE 18 AND MAY REMAIN IN THE CARE OF DYRS UNTIL THE AGE OF 21. THE AGENCY PROVIDES COMPREHENSIVE SUPPORT SERVICES TO COMMITTED YOUTH IN OUR SECURE FACILITIES AS WELL AS WITHIN THE COMMUNITY. DYRS IS DESIGNED TO HELP YOUNG PEOPLE GET ON THE RIGHT TRACK AND SUCCESSFULLY TRANSITION INTO ADULTHOOD.
- DYRS WORKS WITH FELLOW DISTRICT AGENCIES, COMMUNITY PARTNERS, AND JUVENILE JUSTICE EXPERTS TO ACHIEVE THESE GOALS. DYRS COLLABORATES TO IMPLEMENT INNOVATIVE, RESEARCH-BASED MODELS THAT ALIGN WITH BEST PRACTICES IN THE JUVENILE JUSTICE AND YOUTH DEVELOPMENT FIELDS.

### PLC OVERVIEW

- PROGRESSIVE LIFE CENTER (PLC) PROVIDES QUALITY MENTAL HEALTH AND SOCIAL SERVICES
  TARGETING INDIVIDUALS, FAMILIES, ORGANIZATIONS AND COMMUNITIES IN THE DISTRICT OF
  COLUMBIA, MARYLAND, DELAWARE AND PENNSYLVANIA.
- AS A <u>COA ACCREDITED</u> SERVICES PROVIDER, PLC OFFERS TREATMENT AND TRADITIONAL FOSTER CARE, KINSHIP CARE, YOUTH DIVERSION, FAMILY PRESERVATION, AND CULTURAL DIVERSITY AND TEAM BUILDING TRAINING. PLC ALSO OFFERS MENTAL HEALTH SERVICES DIRECTLY TO THE PUBLIC.
- PLC PROGRAMS ARE SHAPED BY A CORE BELIEF IN THE INNATE STRENGTH OF THE INDIVIDUAL, THE INFLUENCE OF FAMILY, AND THE SUPPORT OF THE COMMUNITY TO POSITIVELY IMPACT AND CHANGE BEHAVIOR LONG-TERM.

# BUILDING BLOCKS DC MINI-GRANTS OVERVIEW

- THE OFFICE OF GUN VIOLENCE PREVENTION (OGVP) PARTNERED WITH THE DEPARTMENT OF YOUTH REHABILITATION SERVICES (DYRS) AND PROGRESSIVE LIFE CENTER (PLC) ON THE DISTRIBUTION OF GRANTS TO COMMUNITY MEMBERS ENGAGED IN EFFORTS AIMED AT REDUCING GUN VIOLENCE IN THOSE NEIGHBORHOODS MOST AFFECTED.
- BEGINNING THIS YEAR, OGVP WILL BE INCREASING THE AMOUNT OF MINI-GRANT AWARDS TO AS MUCH AS \$15,000 BASED ON EVIDENCE OF POSITIVE PAST PERFORMANCE AND FINANCIAL COMPLIANCE. THIS PROCESS WILL BEGIN WITH THE SPRING 2023 GRANTS.
- FOR THE WINTER, THERE IS ONE TYPE OF GRANT AVAILABLE:
  - \$5,000 MINI-GRANTS WILL BE AWARDED TO INDIVIDUALS, ORGANIZATIONS, ETC. TO CREATE ACTIVITIES THAT ENGAGE RESIDENTS, LEADERS, AND ORGANIZATIONS IN PROMOTING PUBLIC SAFETY.

### BUILDING BLOCKS DC GRANTS OVERVIEW

- PRIORITY WILL BE GIVEN TO THOSE DISTRICT LOCATIONS AFFECTED BY RECENT GUN VIOLENCE. CATEGORIES INCLUDE THE FOLLOWING BUT ARE NOT LIMITED TO:
  - COMMUNITY WEALTH
     SKILLS BUILDING, LEADERSHIP DEVELOPMENT, COMMUNITY COHESION & ENCOURAGEMENT,
     PROVIDING SUPPORT OF BASIC NEEDS
  - COMMUNITY REVITALIZATION
     COMMUNITY ORGANIZING ACTIVITIES, NEIGHBORHOOD OUTREACH
     PROVIDING ACTIVITIES IN A SAFE SPACE, MURALS, BLOCK CLEANING, COMMUNITY GARDENS
  - COMMUNITY HEALING
     COMMUNITY RESPONSES TO VIOLENCE, RESTORATIVE JUSTICE SUPPORTS
     DIRECT INTERVENTION ACTIVITIES, HEALING/MENTAL WELLNESS

### BUILDING BLOCKS DC GRANTS OVERVIEW

#### • ELIGIBLE APPLICANTS:

 INDIVIDUALS, COMMUNITY-BASED NON-PROFIT GROUPS AND ORGANIZATIONS, CLERGY GROUPS, OR SMALL BUSINESSES LOCATED IN THE DISTRICT OF COLUMBIA IS ELIGIBLE TO APPLY. FOR PROFIT ORGANIZATIONS ARE ELIGIBLE BUT MAY NOT INCLUDE PROFIT IN THEIR GRANT APPLICATION. FOR-PROFIT ORGANIZATIONS MAY ALSO PARTICIPATE AS SUBCONTRACTORS TO ELIGIBLE AGENCIES.

#### LENGTH OF AWARDS:

• THE ANTICIPATED GRANT AWARD PERIOD IS JANUARY 16<sup>TH</sup> TO FEBRUARY 12<sup>TH</sup>, 2023.

  - NO APPLICATIONS WILL BE ACCEPTED AFTER 5PM ON FRIDAY, DECEMBER 2<sup>ND</sup>
  - FOR THIS COMPETITION, 25 GRANTS WILL BE AWARDED

#### REVIEW PROCESS

- ONLY COMPLETED APPLICATIONS WILL BE READ AND SCORED BY REVIEWERS
- EACH APPLICATION WILL BE SCORED BY MULTIPLE REVIEWERS
- REVIEWERS WILL MAKE RECOMMENDATIONS ON PROPOSALS TO BE AWARDED
- THE FINAL DECISION ON ALL AWARDS WILL BE MADE BY OFFICE OF GUN VIOLENCE PREVENTION DIRECTOR
- ALL AWARDED AND NOT AWARDED APPLICATIONS WILL RECEIVE EMAIL NOTIFICATION BY FRIDAY, DECEMBER 23<sup>RD</sup>

# BUILDING BLOCKS DC MINI GRANTS OVERVIEW

#### AWARD PROCESS

- AWARDED APPLICANTS WILL SUBMIT A W9 IN ORDER TO RECEIVE AWARD FUNDS (NOT TO EXCEED \$5,000)
- AWARDED APPLICANTS WILL BE REQUIRED TO SUBMIT BANK ACCOUNT INFORMATION AND A VOIDED CHECK
- AWARDED APPLICANTS WILL RECEIVE A CONTRACT THAT MUST BE SIGNED AND RETURNED TO PLC BEFORE PAYMENTS WILL BE MADE
- AWARDED APPLICANTS WILL BE REQUIRED TO MEET WITH PLC ACCOUNTING, IN PERSON, TO CONFIRM ALL REQUIRED DOCUMENTS HAVE BEEN SUBMITTED AND TO CLARIFY RECONCILIATION DOCUMENTATION (MEETINGS WILL BE HELD BETWEEN DECEMBER 26<sup>TH</sup>, 2022, AND JANUARY 13<sup>TH</sup>, 2023)
- AWARDED APPLICANTS WILL BE ASKED TO GIVE A TIMELINE FOR WHEN THEIR PROJECT WILL BEGIN AND END
- AWARDS WILL BE MADE BY DIRECT DEPOSIT
- ALL APPLICANTS MUST SUBMIT PROOF OF EXPENDITURES WITH 5 BUSINESS DAYS OF THE COMPLETION OF THE PROJECT OR NO LATER THAN FRIDAY, FEBRUARY 17<sup>TH</sup>, 2023

- REPORTS AND/OR PICTURES AND/OR VIDEO WILL BE USED TO DOCUMENT PROJECT IMPLEMENTATION AND COMPLETION
- OGVP/PLC WILL ASSESS IMPACT OF PROJECTS
